

## **Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) Emergency Funds**

The Federal Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA), 2021, has allocated emergency financial aid grants called the Higher Education Emergency Relief Fund (HEERF) II. The purpose of the funding is to award emergency financial aid grants to students for expenses related to the disruption of campus operations due to the coronavirus pandemic.

Bryan University (OPE ID: 03066300) received education stabilization funds under section 314 (a)(4) of CRRSAA. This Fund Report applies to the student portion received under the Higher Education Emergency Relief Fund II (CRRSAA) that is designated exclusively for emergency financial aid grants to students.

The institution has received these funds and is distributing them in accordance with the CRRSAA and implementing guidance.

The institution is making the below information available for transparency purposes and in compliance with the U.S. Department of Education's ("Department") Electronic Announcement of May 13, 2021. As required by the Department of Education, Bryan University is providing information regarding the CRRSAA Act funds:

1. Bryan University signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA 314 (a)(4) program to provide Emergency Financial Aid Grants to Students.
2. The total amount of funds Bryan University will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA 314 (a)(4) program is \$172,826.
3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA 314 (a)(4) program as of the date of submission (i.e., as of the initial report and every calendar quarter thereafter) is \$0.
4. The estimated total number of students at the institution eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA 314 (a)(4) program is 188 students.
5. The total number of students who have received an Emergency Financial Aid Grant to Students under CRRSAA 314 (a)(4) program is 0.
6. The method Bryan University used to determine which students may receive Emergency Financial Aid Grants and how much they may receive under the CRRSAA 314 (a)(4) program is as follows:
  - a. Students must be U.S. Citizens or eligible non-citizens.
  - b. Students must certify they have completed a 2020-2021 FAFSA.
  - c. Students must certify that emergency grant funds are used to assist with expenses incurred in direct relation to the coronavirus pandemic and only the following expenses can be included; tuition, food, housing and utilities, healthcare (including mental health care), and childcare.
  - d. Students must certify they are current students and working towards a degree or certificate from Bryan University (Student statuses of active, active-LOA and Future Start meet eligibility requirements. Student statuses will be verified when funds are requested from the Department of Education).

- e. Students must complete the CRRSAA Student Acknowledgement form and return to Bryan University no later than 11.59p on May 21<sup>st</sup>, 2021. The form may be completed and submitted via hardcopy or electronically.
  - f. Students must certify that all answers, information, and documentation (if applicable) provided is complete, true, and accurate to the best of their knowledge. They understand that any misrepresentation, falsification, or omission of any facts in the acknowledgement may result in funds being denied.
  - g. Emergency grant amounts are determined based on the number of CRRSAA Student Acknowledgement forms received and number of eligible students. The emergency grants will be divided equally and in a way that prioritizes eligible students with exceptional need and ensures that funds are distributed as widely and expeditiously as possible, per federal guidance. CRRSAA funds will be allocated directly between students based on the following two groups:
    - Group 1 – Funds will be allocated directly to students who have filed a 2020-2021 Free Application for Federal Student Aid (FAFSA). The amount of each grant is determined by the FAFSA's calculated Expected Family Contribution (EFC). Students with a calculated EFC between \$0 and \$5,711.00 will receive an amount that does not exceed the maximum amount of the 2020-2021 Federal Pell grant award (\$6,345.00)
    - Group 2 – Funds will be allocated directly to students who have filed a 2020-2021 Free Application for Federal Student Aid (FAFSA). The amount of each grant is determined by the FAFSA's calculated Expected Family Contribution (EFC). Students with a calculated EFC between \$5,712.00 and higher will receive an amount that does not exceed the maximum amount of the 2020-2021 Federal Pell grant award (\$6,345.00) and is less than the amount disbursed to Group 1.
  - h. Bryan University does not guarantee that all CRRSAA Student Acknowledgements submitted are eligible for funding.
